COMBINED NOTICE OF PUBLIC HEARINGS AND PUBLIC COMMENT PERIODS FOR THE 2021 ANNUAL ACTION PLAN AND SUBSTANTIAL AMENDMENT TO THE 2020 ANNUAL ACTION PLAN

NOTICE IS HEREBY GIVEN that the Washington County Community Development Agency is accepting public comments beginning March 19, 2021 through April 20, 2021 on the Washington County 2021 Annual Action Plan and Proposed Amendment to the 2020 Annual Action Plan. The Annual Action Plans outline the use and activities of Community Development Block Grant Program (CDBG) and Home Investment Partnerships Program (HOME) funds that will help address the high priority needs and objectives of the 2020-2024 Consolidated Plan. This also amends the 2018, 2019 and 2020 Action Plans.

Funding is based on 2021 allocations and program income received to date of this publication. Any further program income received will be applied proportionately to the activities by the amount needed to meet the final funding allocation. The following are proposed uses for the 2021 Program Year:

- Two Rivers Community Land Trust: \$90,220 (HOME) and \$75,530 (CDBG) to acquire, rehabilitate and resell three owner-occupied units of affordable housing to low-moderate income homebuyers in Washington County.
- Twin Cities Habitat for Humanity: \$300,000 (HOME) for new construction of four Washington County owner-occupied units of affordable housing to low-moderate income homebuyers.
- Washington County Home Improvement Loan Program: \$380,857 (CDBG) to provide deferred loans to low-moderate income households for home improvements.
- Washington County: \$105,320 (CDBG) to provide homeless prevention services and assistance in Washington County.
- Washington County CDA: \$140,427 (CDBG) and \$34,073 (HOME) for program administration.
- Community Development Housing Organization (CHDO): \$45,483 available for a Consortium-Wide project.

2020 Annual Action Plan Amendment:

Under Coronavirus Aid, Relief, and Economic Impact Act (CARES Act), waivers were provided for Program Year 2019 and 2020, including the 15% public services activities cap. In order to exercise these waivers, Washington County will reallocate funding provided to the 2020 Home Improvement Loan Program and Program Administration projects to public service projects. Any additional program income received will be applied proportionately to the activities by the

amount needed to meet the final funding allocations for 2020 thus decreasing the amount needed from the Home Improvement Loan Program and Administration.

Proposed 2020 Annual Action Plan Amendments:

- Swap funding in the amount of \$300,000 CDBG funding (Administration \$173, 158 +/-, Home Improvement Loan Program \$40,000 +/-, and unallocated/program income \$86,842 +/-) to public service activities:
 - Washington County Homelessness prevention services staffing \$150,000
 - Washington County CDA homeownership services \$15,000
 - Washington County CDA homeownership grants \$135,000
